Letter to Property Owners of Cedar Springs Filings 1 & 2 from Cedar Springs Improvement Association:

Welcome to the Storm Mountain community. We are happy to have you here. Your property lies within Cedar Springs Estates Filing 1 or Filing 2. As originally conceived, Cedar Springs Estates consisted of Filings 1 through 4, and all four filings were platted under Cedar Springs Estates, a subdivision. The Cedar Springs Improvement Association owns and is responsible for maintaining the lake in Filing 1 and all other common areas in the subdivision. Even though property owners in Filings 1 & 2 use the lake, because of the developer's failure to file covenants they are not subject to Association covenants.

The continuation, purpose, and responsibility of the Cedar Springs and Cedar Park Homeowners groups will be determined by those individual groups and have no bearing on the functionality, budget, and purpose of the Storm Mountain PID and/or Board.

All funding for the Storm Mountain PID is derived through the tax assessment and collection process of Larimer County; acting as the agent of the Storm Mountain PID Board, and all funds collected or contained by other homeowner groups or associations within the Storm Mountain Community have no bearing on the PID business.

Consider joining the Storm Mountain Yahoo group, which is open to all residents and property owners of the Storm Mountain area. It's a great way to keep up with happenings in the community.

You'll need to sign up for a Yahoo user ID / email address if you don't already have one, and use that when you join the group. You can do this from the Sign Up link near the top of the Yahoo main page: <http://www.yahoo.com/>. Sign in to Yahoo with your ID – the Sign In link near the Sign Up link on the same page above.

The Storm Mountain Yahoo group has a web site at the link above. You can join the group by clicking through the "Join This Group" button on the main group page, or by emailing John Green (email address is below) to ask to be sent an Invitation email. It works best if you are signed in to Yahoo when you click on the link in the invitation email.

This is a closed group, meaning that a group moderator will need to approve your membership request, which shouldn't take more than a day. You'll know you're successfully a member of the group when you are signed in to Yahoo and the "Join This Group" button no longer shows up on the main group page.

After you are a member and can log in to the group main page with your yahoo ID, you'll also probably want to use the "Edit Membership" option (under the "Membership" menu on the group main page) to configure your group membership so that email messages from the group are sent to an email address you check regularly. If your email provider allows you to create a "whitelist" of email addresses that you never want to be considered spam, add the

group email address below to your whitelist – otherwise, check your junk mail / spam folder regularly for mis-categorized email messages from the group.

Once a member, you can send email to the group by addressing it to: [stormmountain@yahoogroups.com](mailto:stormmountain@yahoogroups.com) and sending it from an email address that is listed in the “Edit Membership” area. Also please check out the documents in the various Files area – you may find some of interest, like the one written about Radon and Uranium in the water. You can see past messages in the Messages area, which will help you catch up with recent conversations. All members are free to post files and photos as well as messages.

If sometimes you find you aren’t able to access files etc. on the group website even though the upper left corner of the main page shows that you are signed in, look to see if the “Join This Group” button appears along the right side of page. That button only displays when the web page thinks you aren’t a member of the group. If so, sign out from Yahoo and sign back in with your Yahoo ID before going back in to the group web site. This should fix the problem.
